Facility Rental Terms and Conditions

Rental Fees

Fees will be applied as quoted by the Richmond Hill Lawn Bowling Club (RHLBC).

Cancellation Terms

The client must give notice of cancellation at least 24 hours prior to the event time unless the cause of the cancellation is due to weather or some other uncontrollable or unforeseeable reason. See Advance Deposit terms regarding special services. The client may reschedule to an alternate date.

If weather conditions or other uncontrollable cause is harmful to the lawn bowling Green or makes it un-useable as deemed by the Club's Greens Keeper, the RHLBC reserves the right to cancel and will do so with the earliest possible notice. If the event is cancelled by the RHLBC, the client will have the option to reschedule to an alternate date.

Compensation

Payment by cash or cheque is due in full on the day of the event.

Advance Deposit

A deposit will be required if the RHLBC is providing a special service for which it will incur costs. The amount of the deposit will depend on the expected cost outlay for the special service. The deposit will be non-refundable if the client cancels the event within **48** hours of the event time. The deposit will be refunded in full if the RHLBC cancels the event.

General Terms

The Richmond Hill Lawn Bowling Club does not have a liquor license therefore the sale of alcohol is strictly prohibited. If the client wishes to sell alcoholic beverages they must apply for their own permit from the proper authorities. The client must assume full responsibility for the distribution of the alcoholic beverages and the actions and consequences of the client's party and absolve the RHLBC, its directors and members of any liability.

The RHLBC Clubhouse is a non-smoking facility. A separate smoking area is located at the front gate. Visitors are not permitted to use the maintenance shed or maintenance equipment.

Indemnification

The client will agree to compensate the RHLBC and/or its members for costs for damage to person, property, business loss or loss of enjoyment caused by fault, negligence or willful acts of the client or members of the client's party.

Liability

The client will agree to release from all liability and forever discharge the Richmond Hill Lawn Bowling Club (RHLBC), its members, directors, officers, instructors, volunteers, coaches, agents, suppliers and property owners, and the Town of Richmond Hill, from any and all actions, causes of actions, claims and demands for damages, loss and/or injury, however arising, whether the result of bodily injuries, illness, or death to person, or loss or damage to personal property which heretofore may have been or may hereafter be sustained by members of the client's party as a consequence of participating in the described event.
